

## *Privacy policy*

This privacy policy defines and informs you of how EV Real Estate Services Sarl uses and protects the information you may provide to us, where applicable, when you use this website accessible at the following URL: <https://evres.ch/> (hereinafter the "Site").

Please note that this privacy policy may be amended or supplemented at any time by EV Real Estate Services Sarl, in particular in order to comply with any legislative, regulatory, case-law or technological developments. In such case, the date of its update will be clearly identified at the top of this policy. These changes are binding on the User as soon as they are published online. Users should therefore consult this privacy policy and cookie policy regularly in order to be aware of any changes.

### **Personal data**

In general, you can visit the Site <https://evres.ch/> of EV Real Estate Services Sarl without providing any personal information about yourself. In any event, you are in no way obliged to provide such information to EV Real Estate Services Sarl.

However, if you refuse, you may not be able to benefit from certain information or services you requested. In this respect, EV Real Estate Services Sarl may in certain cases ask you to provide your last name, first name, email address, telephone number, company/organization and position (hereinafter your "Personal Information"). By providing this information, you expressly agree that it may be processed by EV Real Estate Services Sarl for the purposes set out in section 2 below, as well as for the purposes stated at the end of each form.

In accordance with the General Data Protection Regulation (GDPR) adopted by the European Parliament on 14 April 2016, and with the French Data Protection Act of 6 January 1978 as amended, EV Real Estate Services Sarl informs you of the following:

## 1. Identity of the data controller

## 2. Purposes of processing

EV Real Estate Services Sarl may process your Personal Information:

- (a) in order to provide you with the information or services you have requested (in particular: registration for the conference, sending registration confirmation, your invoice, your login credentials, the newsletter); and/or
- (b) in order to collect information enabling us to improve our Site, products and services (in particular through cookies); and/or
- (c) in order to contact you about various events relating to EV Real Estate Services Sarl.

## 3. Recipients

Only EV Real Estate Services Sarl is the recipient of your Personal Information. This information, whether in individual or aggregated form, is never transmitted to a third party, notwithstanding the subcontractors used by EV Real Estate Services Sarl (you will find more information about them in section 7 below). Neither EV Real Estate Services Sarl nor any of its subcontractors markets the personal data of visitors and Users of its Site.

## 4. Retention period

Your Personal Information is kept by EV Real Estate Services Sarl only for the period corresponding to the purpose of collection as indicated in section 2 above and, in any event, for no longer than 24 months.

## 5. Data protection rights

You have the following rights regarding your Personal Information, which you may exercise by writing to us at the postal address mentioned in section 1.

### **Right of access and communication of data**

You may access the Personal Information concerning you.

However, due to the obligation of security and confidentiality in the processing of personal data incumbent on EV Real Estate Services Sarl, you are informed that your request will be processed subject to you providing proof of your identity, in particular by producing a scan of your valid identity document (if you apply via our dedicated online form) or a signed photocopy of your valid identity document (if you submit your request in writing).

EV Real Estate Services Sarl informs you that it may, where applicable, object to manifestly abusive requests (by reason of their number, repetitive nature or systematic character).

To help you in your procedure, in particular if you wish to exercise your right of access by written request to the postal address mentioned in section 1, you may use a template letter prepared by the French Data Protection Authority ("CNIL").

### **Right to rectification of data**

Under this right, the legislation entitles you to request the rectification, updating, restriction or deletion of data concerning you that may, where applicable, be inaccurate, erroneous, incomplete or obsolete.

You may also define general and specific instructions regarding what happens to your personal data after your death. Where applicable, the heirs of a deceased person may request that their relative's death be taken into account and/or that the necessary updates be made.

## *Privacy policy*

To help you in your procedure, in particular if you wish to exercise, on your own behalf or on behalf of a deceased relative, your right to rectification by written request to the postal address mentioned in section 1, you may use a template letter prepared by the CNIL.

### Right to object

The exercise of this right is only possible in one of the following two situations:

When the exercise of this right is based on legitimate grounds; or

When the exercise of this right is intended to prevent the data collected from being used for commercial prospecting purposes.

To help you in your procedure, in particular if you wish to exercise your right to object by written request sent to the postal address indicated in section 1, you may use a template letter prepared by the CNIL.

### Response times

EV Real Estate Services Sarl undertakes to respond to your request for access, rectification or objection, or any other additional request for information, within a reasonable period not exceeding 1 month from receipt of your request.
